Scott Fehlman 7824 Campton Cir NW North Canton discussed the accident of an 8 year old boy on Labor Day that was hit by a car. He stated that the car left the scene. He also wanted to address speed. Mr. Sabo also spoke about speed tables.

Also, he mentioned the trees and fences. Mr. Sabo addressed Ohio and the placement of stop signs. Dan stated that he has signatures on a petition. Mr. Haws stated it will still depend on the Ohio Revised Code uniform traffic control through the county engineers office and their professional opinion. Mr. Haws also stated this will take a few weeks.
