Bob McCarthy 8638 Marsh Ave has concerns about a dump near his home. Mr. Haws discussed that Plain Township does not have a dump and that this issue is about a specific private property. Mr. Haws noted that there are laws and rules that the Township is bound by. Eric Williams spoke about the issue from a legal perspective and determining things of value.
